

# TERMS AND CONDITIONS

## Introduction

Welcome to the Free AED Recycling Program. These Terms and Conditions (“Terms”) govern your use of the Free AED Recycling Program Site (“Site”) and participation in the Free AED Recycling Program, hereafter referred to as “the Program”. Please read these Terms carefully. By participating in the Program, you consent to these legally binding Terms as well as our Privacy Policy, which is hereby incorporated. These Terms are in addition to and not intended to replace or supersede the Terms and Conditions of the AED One-Stop Shop [website](#).

## Consent and Capacity

In order to use our services, you must be at least eighteen. Your use of our services is conditioned on your acceptance of these Terms. If you do not agree with these Terms, please discontinue your use of the Site. By using our services, you warrant that you are entering into a binding contract with AED One-Stop Shop.

## User Responsibilities

AED One-Stop Shop retains the right to any rebate received from its disposal of any materials received through the Program and to any incentives it may receive from its partnerships with any AED manufacturers or any lithium battery recycling facilities, alliances with biomedical specialists or participation in other AED donation programs.

In line with this belief, you agree that any disputes arising from your use of the Site or participation in the Program will be handled and resolved according to the provisions of these Terms, unless otherwise explicitly stated. If a dispute arises, you agree to first contact us and attempt to resolve any such issues informally. If informal attempts fail, you agree to submit any claim, dispute, or controversy to binding arbitration.

YOU AGREE TO WAIVE ANY AND ALL RIGHTS TO A JURY TRIAL YOU MAY HAVE IN ANY AND ALL JUDICIAL PROCEDURES AND PROCEEDINGS RELATED TO ANY DISPUTE ARISING FROM YOUR USE OF THE SITE OR PARTICIPATION IN THE PROGRAM UNDER THESE TERMS.

ALL PARTIES WAIVE THEIR RIGHTS TO PRESENT CLAIMS IN A CLASS ACTION SUIT.

### **Severability**

If any portion of these Terms is deemed unenforceable, void, or invalid for any reason, the remaining provisions of these Terms will remain unaffected and will not be considered unenforceable, void, or invalid. They will maintain the full force of law to the extent possible.
